Setting the Record Straight Surf City

The last few weeks there has been <u>erroneous information</u> put before the public. The Republican candidates for Surf City Council welcome this opportunity to provide the following information:

<u>CLAIM</u>: Democrat candidates Jack & Lydia Bashwiner assert that the Borough CFO, Attorney, and Department heads do not attend Borough Council meetings.

FACT: For those of you that have attended council meetings you know that, almost always without fail, our Department heads (CFO, Administrator/Clerk, Chief of Police, and Public Works Superintendent) are present at the meetings and are often-times called upon to answer questions. Having our attorney attend means an hourly rate, portal to portal. Unless necessary, we don't require the attorney's presence for that reason.

<u>CLAIM</u>: The Borough of Surf City "only contributes \$25,000 to our Volunteer Fire and EMS Company".

FACT: A monetary contribution of \$25,000 is given to the Surf City Fire and EMS Company but to further assist with the services they provide, Surf City has provided ambulances, fuel and insurances. Approximately \$40,000 per year is contributed to the Length of Service Awards programs for qualifying members. The combination of these contributions total approximately \$120,000 annually. Furthermore, in 2016 a state-of-the-art engine was purchased for just over \$740,000. (Approximately \$760,000 less the sale of two older engines to offset some costs.)

CLAIM: Surf City is in debt.

FACT: By law, bonds must be issued for capital projects as it authorizes the project and the expenditure of funds. As a result of careful spending throughout many years, Surf City can, and does, borrow from itself to fund capital projects. These monies must still be accounted for and that's what you see on the "Annual Debt Statement". In other words, the money is authorized to spend but debt bonds remain unissued. Further evidence that Surf City is not borrowing money is the lack of debt service (interest paid to borrow money). On the other hand, the Bashwiners served their former community of Verona, where in fact, they have accumulated real debt in excess of \$40,000,000!
